

Scarab Creative Arts Artist Gallery Agreement - Individual

Legal Agreement Ownership of the Art

- You warrant that the art you are submitting is your own work, you own all rights to the art, and you take full responsibility for the content of all art.
- Under this agreement, the artist appoints Scarab Creative Arts as agent for the purpose of exhibition and sale.
- The art becomes the property of the buyer at the time of sale.
- You grant Scarab Creative Arts the right to reproduce an image of your art on our website, on social media, and where appropriate to help promote the exhibition and archive the exhibition afterwards.

Shipping

- Should a buyer request shipping of the piece(s) after the show, the artist is responsible for packaging and shipping the piece(s). Buyers will be advised shipping is available, cost to be determined.

Details

- Art will remain in the gallery throughout the duration of the show.
- Unframed canvases should be painted around the outside edge of the canvas.
- Each work must be completely dry--no freshly painted work accepted.
- Framed work must be ready to hang from wire positioned near the top of work.
- At minimum, 50% of the art exhibited must be for sale.
- The Artist assumes responsibility for damage to the gallery resulting directly from actions of the artist and agrees to reimburse Scarab Creative Arts for the cost of repairs.

Liability

- The agreement entered into between gallery owners and the Fresno Arts Council specifies division of responsibilities regarding insurance.
- Scarab Creative Arts does not provide insurance for art exhibited in the gallery and assumes no responsibility for loss incurred due to theft, fire, water, vandalism, or any other natural or man-made occurrence.

Storage

- Art must be picked up in the week following the closing of the show. Times will be announced by email.
- Art left behind will be subject to a storage/handling fee.
- Art left after 90 days will be donated to a charity of our choice.

Commission

- Artist/Gallery Commission for work sold from the Gallery: 70% Artist / 30% Gallery
- Any artist sales through the gift shop or on the premises, either by the artist or by Scarab staff, are subject to the commission schedule: 70% Artist / 30% Gallery
